1. This competition is open to residents of Australia only from 3pm Thursday 1st February to 5pm Wednesday 28th February 2018.

3. To enter persons simply need follow the instructions on the pinned "Win an Apple Watch" Facebook post and comment on the post with the correct location name of a Foote's Pharmacy store.
4. Entrants must also like the page, like the post, tag two friends and share the post to be eligible to enter the random draw.
5. All entrants are required to complete actions as stated and have a legitimate Facebook account to enter. Entrants must be 18 and over to claim the prize. Should the winner be under 18 years of age the prize will be awarded to their parent or guardian.
